Corrective Action Plan District Financial Report

Our auditors, Buffamante Whipple Buttafaro, P.C. provided us with comments derived from their audit of the Falconer Central School District 2023-2024 financial statements. The recommendations and annual audit were discussed with the audit committee and subsequently presented to the entire board of education for approval. For each recommendation included in the audit report, the following is our corrective action(s) taken or proposed that was discussed with our audit committee and our audit firm. For recommendations where corrective action has not been taken or proposed, we have included an explanation.

Unassigned Fund Balance and Fund Balance Reserves

Audit Recommendation: Falconer Central School District's unassigned fund balance as of June 30, 2024 amounted to approximately \$7,731,000. This amount constitutes approximately 25.1% of the 2024-2025 school budget. The District also has certain reserves (debt service) in the general fund that does not appear to be within supported levels of compliance with the recommendations of the New York State Office of the State Comptroller, as evidenced by a recent Comptroller review of the District's reserve funds. The District's unassigned fund balance violated New York State Education Law, which limits school districts from retaining an unassigned fund balance not greater than 4% of the subsequent year's budget. In addition, the debt service reserve has a funding level that does not appear to be in accordance with the interpretation of the New York State Comptroller's Office of New York State Education Law. Falconer Central School District should continue to monitor fund balance throughout the year and continue to review its options with regards to reservation and designation of fund balance. We recommend that the District document its rationale to support the purpose and dollar level of reserves and to ensure it is in compliance with New York State guidelines. In addition, the District should consider transferring the funds held in the General Fund's debt service reserve back to unassigned fund balance as recommended by the New York State Office of the State Comptroller.

<u>Plan of Action:</u> The audit committee will continue to monitor this excess. The District plans to establish and review annually a financial long term plan to provide more accurate projections for budget planning. Review of current fund balance reserve accounts is completed at least annually to support these long term plans. The District will review the general fund balance at least quarterly to determine amounts anticipated at the end of the year for determining amounts to fund reserves. The District additionally has made a conscience effort to transfer the debt service reserve referenced back to the general fund over the past few fiscal years and plans to continue to transfer the remaining amount over to the general fund in the coming fiscal years.

<u>Completion Date:</u> Ongoing through budget development process and long range financial planning. Completion date annually will be yearend, June 30, 2025.

<u>Person/People Responsible for Completion:</u> Board of Education, Stephen Penhollow, Superintendent and Sara Kennison, Business Administrator through budget development and long range financial planning.

Adjusting Journal Entries and Required Disclosures to the Financial Statements

Audit Recommendation: During the current year, adjusting journal entries, along with footnote disclosures were proposed by the auditors and accepted by the District to properly reflect the financial statements in accordance with generally accepted accounting principles. Some of the adjustments and footnotes were related to converting to the full accrual method for GASB 34 purposes. In addition, the financial statements were drafted by the auditor and accepted by the District. AU-C Section 265 entitles Communicating Internal Control Related Matters Identified in an Audit, issued by the American Institute of Certified Public Accountants (AICPA) considers the need for significant adjusting journal entries and assistance when preparing the financial statement to be indicative of an internal controls deficiency. Without assistance, the potential risk exists of the District's financial statements not conforming to GAAP. Although the auditors may continue to provide such assistance both now and in the future, under this pronouncement, the District should continue to review and accept both proposed adjusting journal entries and footnote disclosures, along with the draft financial statements.

<u>Plan of Action:</u> The District has received, reviewed and approved all journal entries and disclosures proposed for the current year audit and will continue to review similar information in future years. Further, the District believes it has a thorough understanding of these financial statements and the ability to make informed judgements based on these financial statements.

Corrective Action Plan Extraclassroom Activity Fund

Our auditors, Buffamante Whipple Buttafaro, P.C. provided us with comments derived from their audit of the Falconer Central School District 2023-2024 Extra Classroom Activity Fund. The recommendations and annual audit were discussed with the audit committee and subsequently presented to the entire board of education for approval. For each recommendation included on the extraclassroom activity fund management letter, the following is our corrective action(s) taken or proposed that was discussed with our audit committee and our audit firm. For recommendations where corrective action has not been taken or proposed, we have included an explanation.

Point of Sale Records

<u>Audit Recommendation:</u> We noted several instances where the receipts of cash lacked point of sale records. Each cash receipt received by the central treasurer should be accompanied by supporting documentation which reconciles cash received to participation times rates/fees. Due to the lack of point of sale records, cash receipts are not adequate to permit the application of the necessary auditing procedures to indicate whether receipts were recorded. We recommend that point of sale records be filled out in detail or an appropriate summary by the student treasurer or teacher advisor, and be verified or received by the central treasurer.

<u>Plan of Action:</u> The district, specifically the central treasurer, will update the requirements for cash receipt documentation in the yearly extraclassroom fund procedures manual to be distributed to all extraclassroom fund activities. She will also continue to work with students and club advisors to ensure proper point of sale documentation accompanies all transactions when turned into the business office.
