CALL TO ORDER BY THE PRESIDENT:

BUDGET HEARING

Chairman Ognibene invited Superintendent, Stephen Penhollow, to comment on the proposed budget. Mr. Penhollow provided an overview of the proposed budget.

Chairman Ognibene directed District Clerk, Sara Kennison, to advise dates when the Notice of the Annual Meeting and District Budget Vote was published. Ms. Kennison stated the notice was published on April 1st, 11th, and 27th. The notice will also be published on May 9th, 2022.
