The meeting was turned over to Chairperson Woodard.

Chairperson Woodard invited Superintendent, Stephen Penhollow, to comment on the proposed budget. Mr. Penhollow provided an overview of the proposed budget. There were questions on the definition of central services and the timing for the replacement of roofs. A discussion was held.

Chairperson Woodard directed the Assistant District Clerk, Jamie Bowman, to advise dates the Notice of Annual Meeting and District Budget Vote was published. The notice was published in the Jamestown Post Journal on March 31, April 10, April 26, and will be published on May 23, 2023.
